2. Minutes and matters arising from the November 11th, 2024, meeting Need to appoint an auditor

3. Officer's Reports

Chair

It might be more popular and accessed by a wider and possibly younger audience? Maybe one for the future? Chair will continue to email updates on a regular basis, any member who does not wish to receive the emails can opt out by replying and their name will be removed from the email list.

Treasurer

Runs co-ordinator

- A couple of MTB rides have appeared on the runs list recently which is nice to see although they may not have gone ahead due to the weather.
- There is a lack of rides currently posted on the runs list, most likely due to the variable weather, Mike B to send out an email to ride leaders to encourage a few more to post rides, even if they are later cancelled due to weather or any other reason.
- Maulds Meaburn will be closed for the winter weeks (5 weeks?), so we need an
 alternative for the runs list, Granny Dowbekins, or Upfront might be suitable.
 Suggestion of the new café on the A6 at Hexham, to be checked out to see if it is
 suitable.
